I. INTRODUCTION

“One result of the {failed Global Drug War} has been a terrible escalation in drug-related violence, corruption and **gross violations of human rights** in a growing number of **Latin American countries**.”

Former *American President* Jimmy Carter, New York Times newspaper Op-Ed, “Call Off the Global Drug War, 6/16/2011.”

Until this BRCA, Inc. Legal Brief as Victims requesting an Investigation and Trial by The Hague ICC the Netherlands based on a case study assembled since 1998; most people including the astute and compassionate Former *American President* Jimmy Carter did not realize that “**gross violations of human rights**” have occurred and still are occurring in America and Great Britain naturally as “the core” of this Global Drug War.

This is “*morally suspicious*” since these two countries a little over 150 years ago were in the middle of illicit drug trade of **Opium from China** for example and even went to war over it as it corrupted their governments and their oligarchs. Historically, the **illicit drug trader oligarchs** and their **organized crime syndicates** were *demonically dominated* as they do not believe in God, worship the devil in sex orgies and animal and child and adult human sacrifice rituals. Such people live to exploit, parasite and humiliate humankind.

In the past the **illicit drug trader oligarchs** and their **organized crime syndicates** annually made billions of dollars on trading in **international black African slaves** as well as on **trading illicit drugs**. After the Civil War the answer to the “post slavery problem” of what to do with the idle unemployed black African male and female in America has been the further development of federal penitentiary and prisons and state prisons and jails.

The **rush to invade Afghanistan in 2003** was clearly motivated by the need to take revenge for the heavy Great Britain’s military and political defeat in trying to colonize Afghanistan in the nineteenth century at the **hands of the Afghan Opium Warlords**. Under the **American President George W. Bush Jr. Administration** the trafficking of opium in Afghanistan **increased to a level twice** that of the Taliban period of rule of Afghanistan pre-2003 which was on the decrease according to CIA data.

In other words it is our opinion as its human rights violations “crimes against humanity” victims the American Drug War is disingenuous *a priori* and was bound to fail as it was never intended to succeed; but instead was declared in order to:

- a.) misuse the power that making something “illicit” makes it a black market item and thus encourages disorganized and organized crime to produce and distribute it;
- b.) incarcerating persons in prisons and jails becomes a business and law enforcement grants for Drug War equipment produced billions of dollars of contracts to the military complex organizations that also specializes in “anti-terrorist” products;
- c.) useful to target, control and destroy the left wing communities whose politics are too liberal; as well as the educated leadership of the minority Afro --American, the Native American and Hispanic communities of America.

I. INTRODUCTION (continued)

A. Jurisdiction

Undoubtedly, the Governments and Nations of the United States of America (USA) and United Kingdom of Great Britain (UKGB) which are leading the Global Drug War (GDW) are the most formidable national duo allies in the world financially, militarily, power and influence. But both have shown that their governments' law enforcement and judicial systems can not handle legitimate human rights violations and consider it as an unavoidable collateral damage in their Drug War activities.

1.) American Government Lapses in Drug War Human Rights Protection

- a.) The **US Supreme Court** in July, 1997 repeals the US Religious Freedom Restoration Act (RFRA) of 1993 in a decision of a case of relative Irrelevancy between a Texas municipality and a church and subjects Authentic Rastafarian and Native American Church Members to an expanded targeted Drug War.
- b.) The **US Federal Court System** establishes and defends the human rights of an Authentic *Rastafarian* Minister to have over 50 pounds of Marijuana (*cannabis sativa*) for his church membership on the Territorial Island of Guam but this right because of the Drug War has not been extended to other US Citizens in the United States of America who are Authentic *Rastafarians*.
- c.) Since the 1920's the **US Federal Government** continues to misclassify Marijuana (*cannabis sativa*) as a narcotic when it is actually a weak Psychedelic with tremendous medicinal uses being a recognized Beneficent herb for thousands of years.
- d.) The State of Indiana Superior, Appellate and Supreme Court allowed in 2005 the obvious phony deed confiscation of the BRCA, Inc. Monastery and RD & D Headquarters at 6135 Riverview Drive, Indianapolis, IN. 46208 because of racism and religious prejudice as clearly seen by any objective reviewing of the Court Case Files. Please see Exhibits IX-a through IX-h.

1.) Great Britain Government Lapses in Drug War Human Rights Protection

- a.) The United Kingdom_ Debt Management Office (UK_DMO) which is administering the 1.9 M Euros (\$2.7 M usd) 2007 European Union Humanitarian Grant (EUHG) Award has made it clear it disagrees with the European Union/Special Programmes Body (EU/SPB) headquartered outside the UKGB in Monaghan, Ireland selection of its 2007 EUHG Gift to Pay the Fee and Award BRCA, Inc. founded poverty reduction by George W. Singleton beginning in 1972. As documented in Exhibit V-c every administrative decision by the UK_DMO has delayed, blocked and set up the 1/28/2008 confiscation of the first 2007 EUHG Gift to pay the Fee check for \$310,000 in the 1.9 M Euros 2007 EUHG Award payment to BRCA, Inc.
- b.) The Great Britain Prime Minister and Ambassador GB to the United States as well failed to assist in unblocking the 2009 provision of alternative 2007 EUHG Gift to pay the Fee devised by the EU/SPB. Please see Exhibits V-a and V-b.
