

## **The So-Called Bloodless Coup of the Tilden-Hayes Affair of 1876-77: Resulting Race Riots Targeting Carpetbagger Southern Governments were Bloody**

I. As you might know the disputed American Presidential election of 1876 known as the "**The Tilden (John, NY Governor, Democrat) and Hayes (Rutherford B., OH Governor, Republican) Affair of 1876-77**" has long been cited and talked about by **BRCA, Inc.** in "poverty reduction" discussions as **an extremely important socio-political economic event**. **II. The "Secret Facist Government" in America was born from "The Tilden (John, NY. Governor, Democrat) and Hayes (Rutherford B., OH Governor, Republican) Affair of 1876-77."**

Anton Chaitkin's book "**Treason in America**" covers the "socio-political economic" backdrop to this **Tilden-Hayes Affair** and details the event itself excellently.

The deleterious effects of this deal was the breaking of the "**promise of 40 acre and a mule**" initiated by **American Union Army General Sherman** in South Carolina at the close of the Civil War made to ex-slave and just freed ex-slave black African people. **The Tilden-Hayes Affair** effectively "**reversed the Civil War**" by returning black-ex-slaves to the quasi-slavery of tenet farming based chronic poverty and encouraging Jim Crow laws blocking their economic and voting rights allowing the slave plantation oligarchy socio-political economic control again.

The nation's federal prisons were started and the state jails were expanded to take up the expected load of criminal and unemployed ex-slave blacks \_\_\_ African Americans. **This is why 65% of today's Afro-American males have a jail of prison record during their lifetime.**

**"The Tilden (John, NY Governor, Democrat) and Hayes (Rutherford B., OH Governor, Republican) Affair of 1876-77"** event came about as a result of the bitterly contested **US Presidential Race of 1876** decided by one (1) Electoral College Election Vote cast in a secret session in the Supreme Court which was argued then and now saved a more serious re-outbreak of the Civil War. This must have been the rationale of **Republican President Ulysses Grant** who presided as chief executive during the **Tilden-Hayes Affair**.

The deal that resolved the socio-political crisis of the "**The Tilden (John, NY Governor, Democrat) and Hayes (Rutherford B., OH Governor, Republican) Affair of 1876-77**" constructed in secrecy was that Governor Rutherford B. Hayes would be made the next President of the United States although he lost the popular vote and in return he would pull the Union Armies out of the Southern States. This would effectively end the **Reconstruction Period in America** and end the Carpetbagger Governments that ruled by a coalition of white and blacks in all of those Southern States.

However, we have never been able to find evidence of such a "**murderous coup**" taking place all over the Southern States starting in 1877 when the President Hayes order for military withdrawal from the Southern States was issued. It was as if "his story" or history was silent.

**III.** Please note the incredible article about the just released official commissioned **North Carolina State Government Commission Report** on the "race riot" in the largest city in North Carolina, Wilmington in 1898. This is the first historical evidence of the theorized "murderous coups" that must have taken place after the resolution of the "**Tilden and Hayes Affair**" in 1877.

As an addendum in regards the 1921 race riot that destroyed the **African American Tulsa, Oklahoma neighborhood of Greenwood**; for "national security reasons" the **OK. State Government Commission Report** on that "false black man rapes white woman rape charge instigated race riot" has not issued any response on the rumored unopened mass graves of blacks in the Tulsa, OK. area since its issuance in 2002.

**Note** that it strangely took 21 years for such a "murderous coup" to happen in Wilmington, NC. Why did it take so long? The straw that broke the camel's back that "race riot" day was the stress of the November, 1898 election day results that very day. Clearly, the election must have again been a loss by the Southern Democratic party and so the "race riot" solution" was employed for "**national security reasons.**"

**Note** too that we are to believe that the event of "**The Tilden and Hayes Affair**" generated no other "murderous coups" anywhere else in America from the end of the "**The Tilden (John, NY Governor, Democrat) and Hayes (Rutherford B., OH Governor, Republican) Affair in 1877**" to the Wilmington NC "race riot" on election day 1898.

Again please notice that the event that triggered the Wilmington, NC "race riot" was an election day expected loss again by the Democratic Party at the hands of the Republican white and black coalition called a "Carpetbagger Government" and falsely charged as being corrupt.

The journalist who wrote the article and their editor does notice a "race riot" pattern was allowed by the federal and state governments after 1898 to suppress Afro-Americans starting in the 1900 "race riot" in Atlanta, GA.

**IV. Thus it is herein theorized** that there must have been other "race riots" in other places between 1877 to 1898 not reported yet or to be ever reported; and that from 1900 to 1921 and thereafter to 1954 when the civil rights movement began these "race riots" continued.

This perhaps explains the rumors that the future First Lady Eleanor Roosevelt was aware of her husband's Franklin D. Roosevelt as Secretary of the Navy complicity in the 1921 **The So-Called**

Greenwood, **Tulsa City, OK.** "race riot" as it was reported US military forces including airplanes were clandestinely used in the destruction of Greenwood.

Perhaps there is no coincidence that later as First Lady Eleanor Roosevelt was able to get FDR's support of her becoming the first person to come so close in demonstrating the efficacy of "**sustainable economic developmet**" with an integrated housing and business and job creation project in the middle of the depression that eventually failed to sustain itself.

The official black death toll of the Wilmington, NC "race riot" is set at 100 but that is merely an educated and undocumented guess.

**Notice** that although it is now 107 years since this horrendous "race riot" in Wilmington, NC. that the newspaper articles do not address the socio-political economic reasons why the federal and southern state governments from then on did nothing to stop the **Wilmington race riot in 1898** or to investigate it until now. That would have required a second page and evidently it was of no interest to the articles writers. Would it have been of interest to the articles readers? Yes!! We would have read it.

It is not a coincidence that the New Orleans, LO. was a leading city in the 1992 movement that passed a city council resolution calling for President Bill Clinton to by Executive Order take down the **Albert Pike Washington, DC Monument** waiting for him on his desk his fist day in office and the federal government failed to appropriate enough funds nor the **Army Corp of Engineers** properly over saw the proper building of what levees were built and repaired leading to the destruction and evacuation of New Orleans, LO. 13 years later.

In 2000 we saw the repeat of the 1877 event in the contested US Presidential election which was an event dictated by the need to "cool down" the Internet Revolution based economic development that if allowed to continue would have eliminated poverty for 50% of those legally classified as living poverty including the Afro-American male.
