Dear Addressee:

The reason the FBI has been mentioning the possibility of opening the case of my Father's KKK murder in 1957 is because of the following dedication to his memory on <http://www.theuniversityofgod.org/Page7.html>:

"Dedicated to the memory of my father humanitarian and civil rights activist Dr. George W. Singleton Jr., MD. murdered in 1957 made to look like suicide by the Ku Klux Klan in Shelby, North Carolina, America. This is clearly discerned from an objective analysis of the Coronor's Inquest Investigation Report now "missing" from its county seat file. I read this file in 1976 in the home of the Coronor in question. Again the **US/DOJ/FBI** fails to give my family "equal protection" as his missing gun was found days later exactly where his 4 th degee burned body was found."

There has never been any serious practical interest from me in the **FBI** doing the right thing and opening a 53 year old murder crime case that they suppressed at the time of its perpetration. In similar circumstances ___ Martin Luther King Jr.'s assassination the perpetrators will not be brought to justice on this physical plane because he too was accused of being involved in adultery with white women as my Father.

This KKK's *nonsequitor* hatred of black male and white woman sexual relations stems of course from the slave plantation experience in America and was used to kill a great Afro-American Civil Rights leader in 1968 ___ 11 years after the same scenario occurred with my Father. In both cases the **FBI** was complicit.

I came face to face with the KKK which killed my father and after 53 years and much therapy I have forgiven them.

Even with an Afro-American President in office the King family will not get satisfaction that the FBI reopen the MLK's murder case because of "national security."

However, what I do have interest in is the FBI not interfering with the next attempt by the **European Union/Special Programmes Body (EU/SPB) to pay **BRCA, Inc.'s its 2007 European Union Humanitarian Grant gift to pay the fee and award** of \$2.5 M to the "**OBP**" **ISED** Project so we can demonstrate the **SAF Garden** based **sustainable economic development** including developing a prototype **biological control of malaria** in Africa killing 10,000,000 annually now immorally held up going on 4 years.**
