#### EXECUTIVE SUMMARY:

This is a **Case Study** of the **practical experience and actual process of traveling** to the **Amsterdam the Netherlands** to do the **final preparation and submission** of the **BRCA, Inc. Legal Brief as Victims**. This unprecedented **Request for Investigation and Trial** to the **Office of the Prosecutor (OTP)** and **Pre-Trial Judges of The Hague International Criminal Court (ICC)** was submitted **June 23, 2011**. It cites charges and documents of **significant "crimes against humanity"** by the **American and Great Britain War on Drugs**. The *human rights violation advocate and alledged victim* **George W. Singleton, III (American Passport #475751405)** flew to the **Amsterdam, the Netherlands** after a month predevelopment work in **Ireland** arriving **June 1, 2011**.

For four (4) weeks everything was going perfectly with **complementray WI FI, electricity and work space** from **Starbucks Coffee Cafe and McDonalds Restaurant up to 17 hours a day** **until** the morning of **June 23, 2011** scheduled for the submission to **The Hague International Criminal Court (ICC)** of the **BRCA, Inc. Legal Brief as Victims Request for Investigation and Trial**. Beginning that morning day the *human rights violation advocate and alledged victim* **George W. Singleton, III** experienced the following **additional human rights violations and humiliations**:

- 1.) **June 23, 2011** \_\_\_ **Starbucks Coffee Cafe, 101 Leidsestraat, Amsterdam, the Netherlands** begins to after over 3 weeks of support to request a coffee purchase an hour by Singleton to work there \_\_\_ he left.
- 2.) **June 23, 2011** \_\_\_ the **McDonald Restaurant across the street from Starbucks** requests Singleton leave as he was an undesirable.
- 3.) **July 1, 2011** \_\_\_ the **Central Public Library of the City of Amsterdam the Netherlands** asked Singleton to leave their facility as his body stench was in violations of human sanitary codes.
- 4.) **July 5, 2011** \_\_\_ Singleton is denied access to the **University of Amsterdam Law Library** by the **Head of Security**.
- 5.) **July 7, 2011** \_\_\_ Singleton's 2 of 3 bags are stolen by thieves at bench where he was working for over an hour awaiting **Robobank ATM** funds at Prince of Orange Canal and reported to the **"2 on the beat" Amsterdam the Netherlands Policemen**.  
**Note: Laptop missed by thieves.**
- 6.) **July 13, 2011** \_\_\_ Singleton is questioned at 5 pm by same **"2 on the beat" Amsterdam the Netherlands Policemen as 7/07/2011** as to whether he still had his **laptop** and his **American Passport**. Later that night thieves return and attempt to burglarize Singleton between 2 am and 6 am. in under-bridge free camp site.  
**Note: However, Laptop again missed by thieves.**
- 7.) **July 15 2011** \_\_\_ **Thieves return and burglarize Singleton** in under-bridge free camp site and take his **billfold**.
- 8.) **July 17, 2011** \_\_\_ the same **"2 on the beat" Amsterdam Netherlands Police** demand he leaves **"free camp site under bridge"** in a late night **2:30 am** visit accusing him of **breaking the law sleeping on the street**.
- 9.) **July 20, 2011** \_\_\_ **George Singleton visits Amsterdam Police and US Embassy** about laptop. Embassy implies it is ready to make funds available for food, domicile and/or air ticket.

EXECUTIVE CONCLUSIONS:

**"If Anne Frank and Family were alive and in the same kind of jeopardy as they were in the Amsterdam of the World War II occupied Nazi Germany Third Reich what would be their outcome in Amsterdam, in the Netherlands" of today?** Does using the parameter's of the alledged *human rights violation advocate and alledged victim* George W. Singleton, III (American Passport #475751405) experiences in modern 2011 shed light upon this question?

Note: Yes it is believed that **George W. Singleton's** experience of universal shock by the modern Netherlands people upon their learning of the **brutal denial of his human rights** by the modern Netherlands government and the people wanting to assist him with minor financial donations, with places to stay and food and comradery **was exemplary. It has been deduced** this means they must be delineated from their government in any simulations.

**Consequently, if** left strictly to the simulated human rights record of the modern Netherlands government and the brutal denial of human rights experienced by George W. Singleton, III by the Amsterdam government; Anne Frank and most of her Family would again perish in an Auswitch type (Bergen-Belsen Concentration Camp) genocidal death.
