

Further, the Committee against Torture cannot examine petitions alleging violations of the Convention against Torture (CAT) unless the State has made the declaration under article 22 recognizing the Committee's competence to receive and consider petitions. The United States of America has not made the declaration.

WHEREAS your words quoted in the 2/05/2011 article by the **Reuters News Agency** were very impressive and encouraging where you opposed **Former US President George Bush Jr.'s** fund raising visit to Geneva, Switzerland least he be arrested and tried for alleged torture complaints.

WHEREAS as an American citizen of both African descent and Native American heritage the **Black Indian** experience in America has been especially painful since 1997 as I have suffered significant racial discrimination with genocidal effects and related Rastafarian religious persecution blocking my sustainable economic development and confiscating my economic assets resulting in my homelessness since 2005.

WHEREAS the racial discrimination with genocidal effects and related Rastafarian religious persecution became intense especially beginning in July, 1997 after the repeal of the **US Religious Freedom Restoration Act (RFRA) of 1993** under the **Former US President George Bush Jr. Administration** in America as detailed on <http://www.theuniversityofgod.org/Page22.html>.

WHEREAS the **United Nations General Assembly Resolution 64/169** creating the **2011 International Year for People of African Descent** targeting racism against African descendant people is fulfilling a great need of these people including myself. Singleton III founded in 1992 and have administered since.
